Analytical Highlights for Lot #215398501:

- **Essential Fatty Acid Potency:** Confirmed **DHA at 7.055 mg** and **EPA at 1.718 mg** per serving, both exceeding the minimum specifications for heart and brain health support.
- **Heavy Metals (Purity):** All contaminants (Arsenic, Cadmium, Lead, and Mercury) tested at **< 0.001 ppm**, representing the highest standard of purity and safety.
